Lillian Whitney is asking if we have any documentation as to what has lead the Selectmen to a study. A letter is available from the DEP.

Article #8 No action taken. New Generator is not hooked to the Police Station. Point brought up by committee member as to why we didn't have the original electrician do the work.

Article #9 Park Commission is in charge of watching over the new equipment.

PM states the tractor currently being used is falling apart. He suggested to Stephanie Lammi that she put this article on the warrant. The Ashby Little League was kind enough to donate \$1200 last year for repairs to the tractor that was a hand me down from the Cemetery Commission after they purchased new equipment.

Stephanie Lammi tows the current tractor with her own personal vehicle and her own trailer as a favor to the Town. She also has purchased flowers and mulch out of her own pocket.

Article #21 Article for \$5,000 worth of repairs to Highway Building from accidental damage of trucks hitting the building. Selectmen believe this is cumulative damage over a long period of time. Disapproved by Finance Committee. The money has now been put into the budget for this article and MM questions whether this should be taken off the ballot. Agreed to ask Superintendent if he wants to take this article off now that Finance Committee put more money in the Municipal Buildings line to cover this \$5,000 expense.

Article's #22 thru 25 No Action was taken.

#### Budget:

Map Maintenance from Assessors Account was questioned. Assessors asked for \$6,900 for GIS mapping. FinCom is only approving \$1,600.00.

Question for Administrator: Could someone change this amount on the floor? Any citizen of the town can stand up and change this amount.

Police Budget was left open for discussion: Chief would like to hire 3 reserve officers. They must be Police Academy Trained before they come to Ashby.

New cruiser information was discussed.

MM states he is not in favor of leasing vehicles we end up paying more in the long run.

Council on Aging Budget: They asked for more money and committee reduced the amount they asked for.

Library Building Maintenance: Discussion held. The Finance Committee reduced the amount by two thousand since they claim the gas conversion of furnace will save \$3,500 in the first year of operations.

Question was made as to why the \$20,000.00 increase on Police Line 51. Town Administrator read all of what that increase covered including over \$19,000.00 in IT Expenses.

Notation made that a budget cut could be made to Police Line 51.

Town Administrator stated we need to cut approximately \$5,000.00 for a balanced budget.

Question: PM asked what the Budget Tax Levy Limit is (Prop 2-/1/2)

Answer: \$5,082.470.66

Town Administrator will come in tomorrow and tighten up the new budget figures.

Changes made today were discussed and new figures talked about.
