Selectmen Discuss All Alcoholic Restaurant License fee and hours (Rene Rainville):

SI states other towns have a policy on All Liquor Licenses and he feels Ashby should. JF feels we need to decide to times of operations.

SI obtained copies of other towns and states there is no policy in Ashby. He feels the Board should discuss and have a policy put on the agenda after further discussion. He feels there is a lot more to this then just signing the license. He cited a detainment fee that was on the last warrant due to a DUI incident and feels this should be addressed as part of a policy. He would like to invite the Police Chief to a meeting to get his opinion and input.

MM read some examples from the Town of Marlboro that SI had provided.

JF asked about rules and regulations for the Legion. SI stated he looked it up and they have an entirely different set of rules.

Rene Rainville states he has purchased approximately 70 per cent of materials and is just waiting for the license to be issued to finish the project.

There are State rules and regulations and JF states to RR that the BOS won't be denying his permit but would like to have time to set up a policy for the Town. This could also affect any other business that would like to set up in Town or a change of ownership.

MM would like to find a way to not hold up RR and still be able to adopt a policy.

He asked SI if he would be ok with having weekly meetings until this could be done.

LW asked Rene if he is fully informed as to the State Laws on serving liquor. She also asked him if he has insurance if anything should happen. Answer: Yes. Does he have a procedure in place if a patron gets out of hand? Answer: Yes, call 911. MM suggested talking to Counsel and see if there are any policies for other towns they could look at in the policy making process. RR was acceptable to waiting until the next regular meeting for a policy. JF states it will be on the agenda for the next meeting. LW asked for an explanation of what an "All Alcoholic License" is.

Tree Warden Report Update (Allan Dawson):

Spoke with forestry officials at Willard Brook and no Asian Longhorn Beetles have been found in traps that they had set.

Many ash trees in town may be affected by bores. He is going to have Unitil cut down a tree on his property and check for them. Oak and Maple trees are being seen in Town that are in danger of dying out.

Plans for Town Common: 3 trees that are planted on the Common have not responded to trimming that was done and will be on the way out. He is going to talk to Bill Davis about getting some support from highway. There will be 3 to 5 large stumps that need to be removed and wonders if a warrant article would be necessary for the funding.

Letting the BOS know as of Saturday he would only have about \$800.00 left in his funds. LW spoke about monies that are available for helping towns deal with trees and overgrowth.
