Selectmen discuss and vote on DLTA application for Regional Dispatch Study: Selectmen McCallum presented what this is about. Towns of Ashby, Pepperell and Townsend are studying the possibility of setting up a regional dispatch system for the 3 towns to use jointly. MM states that the State is almost mandating that Towns set up regional dispatch systems by not giving out very large grants to individual Towns that run their dispatches. This is to move forward and apply for a grant to start a study in regards to the possibility of joining the towns of Ashby, Townsend and Pepperell for regional dispatch. MM states we have had a number of meetings with the other towns. Two requirements of the DLTA grant are that it is discussed at a public meeting and BOS sign a letter that states the Town of Ashby is in favor of applying for the grant. MM did talk with the Dispatchers before having this meeting so there are no surprises.
