Bob gave an update on where the budget was now that BOS finished negotiations with new Fire Chief Contract getting another \$10,000 more and how to fund a new Dump Truck for the Hwy Department from 3 different sources: Stabilization, Free Cash and Overlay Surplus.

Kevin Stetson questioned whether due diligence was being done before purchasing these large ticket items. Mike Bussell addressed all the hours of research approx. 80 hours spent before
